Application/Limitation of Use

The lifejacket is approved for use only by adult of weight more than 43 Kg and height more than 155 cm.

To fit person weighing up to 140 kg and with a chest girth of up to 1750 mm, suitable accessories shall be provided.

The lifejacket can be equipped with different position indicating lights and Retro-Reflective materials EC type approved in compliance with Directive 2014/90/EU as amended.

The design assessment is based on IMO Res. MSC.48(66) as amended by IMO Res. MSC.207(81), IMO Res. MSC.218(82) and IMO Res. MSC.368(93).

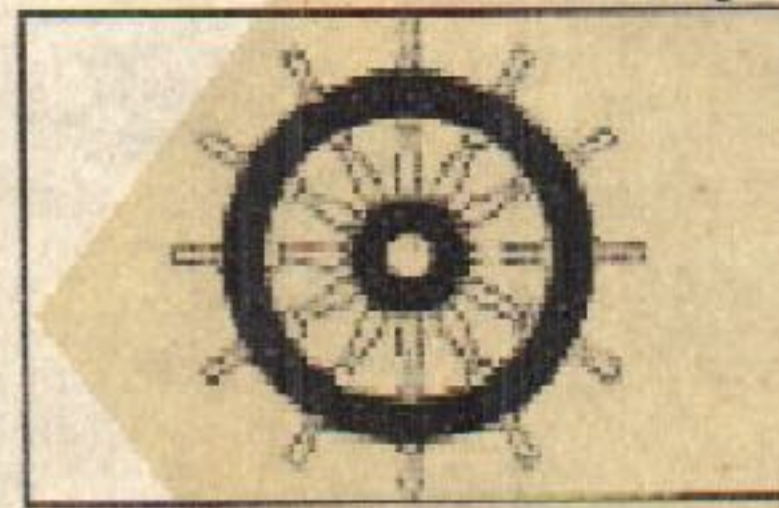
